1. CVRD Year 2 Funding Update

- a. Leadership Team and HDT members met with CVRD to discuss Tiny Homes as an option but were encouraged not to pursue
 - i. Tiny Homes do not meet BC Building Code
 - ii. No municipalities in Canada have approved these yet
 - iii. Looked at funding an elevator at Pidcock House, but unfortunately the cost was over 100k and we only had 50k of funding available
 - iv. Decided that the funds would go to Dawn to Dawn to purchase an additional condo unit
 - v. Remaining funds would go to support the Braidwood project
- b. Betty and Richard updated the CVRD Board on Coalition's Year 1 accomplishments and Year 2 recommendations
- c. The updated 5 Year Plan was passed unanimously and final budget will pass in March, with funds being distributed in August.

2. United Way/Rural Remote HPS funding opportunities

- a. Both due Feb 17th
- b. Who will be applying?
 - i. HPS:
 - 1. Jesse with Wachiay for increased rental top-ups and emergency funding, increased agency collaboration etc
 - 2. Coalition will apply through Transition Society for Drop-In Program and Coordination funds

 - 1. VIRL for the Drop-In Program
- c. Who needs a letter of support?

3. "Designated Community" Status

- i. Federal government has an extensive website on HPS
- ii. Strong on community strategies/collaborations/partnerships for housing first funding
- iii. In the 2014-2019 current funding cycle, 61 communities have 'designated community' status with special funding arrangements, more funding available etc
- iv. Post 2019 should the Coalition apply for this designated community status?
 - 1. Who can apply? a municipality, regional district, First Nation
 - 2. Might need to start a special committee
 - 3. We might encourage CVRD or municipality to apply for status
 - 4. Leadership Team to research and discuss how to move forward

4. Comox Valley Community Foundation 2016 Vital Signs presentation by Jody MacDonald and Harry Panjeer

- a. Vital Signs paints a broad picture of the community using real data
- b. Community Foundations Canada leads this report approximately 30 communities participated for 2016
- c. Report can be accessed at www.cvcfoundation.org
- d. 70% of respondents of the survey were female
- e. "Do you generally have enough money to buy the things you need to live well" Self-identification indicator
- f. Comox Valley poverty rate is 13%
- g. Income comfort level is the key determinant for issues in the community
- h. Health & Wellness
 - i. Depression/anxiety is high in the Comox Valley
 - ii. We have low access to mental health services
 - iii. Child poverty rate is 20% in the Comox Valley
- i. Gap Between Rich & Poor
 - i. Compared to the rest of Canada we have fewer rich people and similar numbers of those in the lower percentage
 - ii. More affordable housing was a high community need to address the gap between the rich and the poor
 - iii. No adequate support for people living in poverty

- iv. Respondents do feel they can earn a livable wage in the Comox Valley
- j. Housing
 - i. More affordable housing units are a top priority for people in the Comox Valley
 - ii. Increased services to homelessness are also a top priority
 - iii. The public supports addressing issues to reduce homelessness
 - iv. Data shows that the older a person is, the more they are concerned about homelessness
- k. Every question in the survey is broken down by age, gender and economic comfort level
- l. Only get responses from those who are interested in taking the survey
- m. Responses were proportional to those living in Courtenay, Comox and Cumberland
- n. Awareness of survey was spread through radio ads, newspaper ads and distributed by service agencies.
 - i. Next time would like to see more collaboration to encourage more responses SD71 for example
- o. Vital Signs is informing strategies for the Comox Valley Community Foundation
