### 1. 5 Year Plan – Year 3 Strategy 1 Funding Information (due Jan 11 to CVRD for Jan 23<sup>rd</sup> board meeting)

- a. Kensington Island Properties
  - i. passed in early December \$250,000 as of Dec 31st has been added to the Homelessness Service Supports Fund
  - ii. also 30 lots over the next 10 years (can be sold or built on)

#### b. BC Housing

- i. Met with Malcolm McNaughton on Dec 8<sup>th</sup> to talk about modular supportive units
- **ii.** BC Housing will match the funds in the CVRD Homelessness Supports Service for the next 5 years

#### c. Year 3 Amount

i. CVRD Regional Services Tax: 150,000
ii. Town of Comox: 30,000
iii. Kensington: 250,000
iv. TOTAL: 430,000

- v. There is potentially another 180,000 in matching funds from BC Housing but it is not confirmed yet so we need to work with the \$430,000.
  - 1. assuming these funds don't have to be allocated at the same time as the CVRD funds, but we will find out.

#### 2. Year 3 HSS Funding Requests (totals \$485,000)

i. CVTS \$160,000 for 4 more units of independent living with 24 hour staffing (supported – not supportive) transitional housing at Amethyst House

- 1. 2 of the units already developed with HSS funds and have been a great success
- 2. Occupied by women who finish the receovery program and some from LILLI House, and single women with infants
- ii. **John Howard Society \$150,000** (renovations to 10 bedrooms for youth at Abbeyfield)
  - 1. Renovations need to be done such as; fixing the roof, ripping out carpet and adding laminate flooring, furnishing suites with kitchen facilities, small fridge, microwave etc
  - 2. Ideally would like an April 1st move in date
    - a. okay with not getting the funding until August
  - 3. Housing for youth has been on the 5 year plan since the start with nothing built to date
  - 4. JHS talking with MCFD about staffing

#### iii. Wachiay/M'akola \$50,000 (towards Braidwood)

- 1. The 50k would be for a second installment towards Braidwood
- 2. Received \$60,000 in Year 2
- 3. Braidwood project is at final approval level with executive team at BC Housing
- 4. Any day now City of Courtenay will issue building permit, BC Hydro info came in over the holidays
- 5. First 40/60k is to come when the building permit comes in
- 6. Supportive-like housing 34 units
- 7. Care-a-van, LUSH Valley, AVI, MHSU are partners agencies who can help put on programming
- 8. Final project approval at BC Housing has changed as prices have gone up, interest rates might go up, construction starting in winter/wet weather period which contributes to an 300-400k increase in funding
- 9. Costs are already coming in from M'akola, permit costs, architects, engineers etc
- 10. Projected occupancy in December 2018
- 11. Parking variance was adjusted 1.5 per unit 53 but got it down to 14 spaces.
- iv. **D2D 50,000** towards mortgage on condos to reduce rents
  - 1. One condo has been purchased and is occupied, in the process of looking for another condo to purchase
- v. **Habitat for Humanity \$75,000** towards 4 houses at Lake Trail development
  - 1. permits in place
  - 2. 2 units to occupancy and 2 to 'lock-up'
  - 3. Next 4 will happen next year

- 4. \$250,000 to run all the services
- 5. Families have been chosen, they must contribute 500 hours of sweat equity, mortgage is paid back to Habitat, no down payment
- 6. Cost is approximately 2 million for the 10 homes
- 7. Construction and supplies costs have gone up about 15-20%
- vi. Coalition members feel there is a great cross section, range of projects across the continuum of housing being proposed for funding

## b. Leadership Team Recommends the following for HSS funding (total of 18 units of housing):

- i. CVTS (160,000 as requested)
- ii. JHS (150,000 as requested)
- iii. Habitat for Humanity (75,000 as requested)
- iv. D2D (45,000 reduction of 5,000 from request)

#### v. TOTAL: 430,000

- c. Wachiay/M'akola not be funded at this time but be moved to year 4 as they currently have \$50,000 funding from last year that they have not accessed yet because of delays.
- d. If we get the BC Housing Matching funds this would leave us with:
  - i. 180,000 (2018 BC Housing Allocation)
  - ii. 180,000 (2019 BC Housing Allocation)
  - iii. 180,000 (2019 CVRD allocation)
  - iv. 540,000 to distribute in year 4 (2019)
- e. Might re-consider Wachiay once we find out about BC Housing matching funds if building has started and money is required.
  - i. Assuming BC Housing funds can be distributed other later in year but we don't know any of that yet.

#### 3. Coalition DISCUSSION of Year 3 HSS Funding Recommendations:

- a. Reminder that only members can vote.
- b. Requirements from CVRD: 5 Year Plan update, what is being built, who is the lead agency, any other community supports, cost, amount needed, performance measures.
  - CVRD makes report, is presented to the board, questions will be asked, then they make recommendations, and then the recommendation goes to board in March
  - ii. When decisions have been made, contracts happen between the agency and the CVRD, it is an extensive process. CVRD withholds 20% until occupancy has happened, and reports on outcomes have been completed
  - iii. Process is similar with the Town of Comox for their \$30,000 agency is selected, presentation happens and council decides
  - iv. Not sure what process will be with BC Housing funds, but likely something similar

- v. Coalition needs a more substantial proposal process
  - Business case listing the issue, challenges, need for funds, budget, what they've done, other sources of funding etc
  - 2. Come up with a scoring rubric and post the EOI forms on our website
- vi. Accountability and responsibility of decisions is still on the CVRD they are relying on Coalition to inform decisions

#### c. Coalition Decision Wachiay:

- i. Braidwood represents 34 units, biggest project out there right now
- ii. This has gone into the planning report to BC Housing
- iii. Propose to leave the \$50,000 in Wachiay and CV Transition could take less its possible for them to build some units to lock up and wait for other funding
- iv. Habitat is also willing to reduce if necessary
- v. With BC Housing money we will hopefully be able get more funding

#### d. Coalition Proposal: New Recommendation for Year 3

- i. Reduce CVTS to \$105k
- ii. Dawn to Dawn \$50k
- iii. John Howard Society \$150k,
- iv. Wachiay \$50k
- v. Habitat \$75k
- vi. TOTAL \$430k
- vii. Consensus decision achieved. 12/12 participating agency members voted yes for the new proposal.

#### 4. Supportive Modular Housing Update

- **a.** Met with BC Housing
- **b.** Delegation to City of Courtenay happened, urgent request for land, motion was made to bring a shortlist of available lands
  - i. Heather to talk to Mayor and CAO
- c. Mayor has tried to make a connection to BC Housing re: Washington Inn land
- d. 682 units across the province have an actual MOU
- e. Scott Fraser meeting tomorrow to discuss the urgency
- f. Behind the scenes work happening at the City council seems supportive, hopefully will have a decision by the end of the month
- g. There may be more funding opportunities coming up in the future, looking for multiple pieces of land
- **h.** Specific resolution from council is needed to proceed

- i. Land is held and ready to be used when projects come up.
